Townhouse Sales Report

First Quarter 2007

This report includes all 1-4 family townhouses having no commercial space that closed in the first quarter of 2007 and were recorded with the City Register, and not only those closed by Halstead Property, LLC. It is meant only as a record of sales, and not as any general statement on the market. Since vital factors like condition and rent regulation status are not presented, properties may not be comparable to other townhouses both on the market and in the report. There were 52 sales of 1-4 family townhouses in Manhattan during the first quarter, 37% more than a year ago. These 52 sales represent less than 1% of the 5,643 townhouses of this kind in Manhattan.
